TRP Sumner PLLC (“TRP”) writes to inform you of a recent event that may affect the privacy of some of your personal information. While we are unaware of any actual or attempted misuse of your personal information, we take this incident seriously and are providing you with information about the event and access to resources so that you can better protect your personal information, should you feel it is appropriate to do so.

What Happened? TRP became aware of unusual activity involving an employee email account and immediately began an investigation, with the assistance of third-party computer forensic investigators. The investigation determined that an unauthorized actor may have accessed a single employee email account on October 2, 2019. While the investigation did not determine that specific information within the account was accessed, we conducted a comprehensive programmatic and manual review of the contents of the email account to determine the type of personal information contained in the account and to whom the information related. TRP’s review of the email account determined that your personal information was present in the account at the time of the incident. To date, we are unaware of any actual or attempted misuse of your personal information as a result of this incident.

What Information Was Involved? Our investigation determined that at the time of the incident, the email account contained information including your <<ClientDef1(Impacted Data)>>.

What We Are Doing. The security of information in our care is among our highest priorities. Upon learning of this incident, we quickly took steps to confirm the security of our email system. We reset the password for the involved account and reviewed our company policies and procedures relating to data security. In an abundance of caution, we are also notifying potentially affected individuals, including you, so that you may take further steps to best protect your personal information, should you feel it is appropriate to do so. Although we are unaware of any actual or attempted misuse of your personal information as a result of this event, we arranged to have Kroll monitor your identity for 12 months at no cost to you as an added precaution. We also provided relevant regulatory notices.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and monitor your credit reports for suspicious activity for the next twelve (12) to twenty-four (24) months. You may also review the information contained in the attached *Steps You Can Take to Help Protect Your Information*. There you will also find more information on the identity monitoring services we are making available to you. While TRP will cover the cost of these services, you will need to complete the activation process.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud and to review your account statements and credit reports for suspicious activity. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

You have the right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. In order to request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

As an alternative to a security freeze, you have the right to place an initial or extended “fraud alert” on your file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years.
