<b>NOTICE OF A DATA BREACH</b>				
<b>What Happened?</b>	We value and respect the privacy of your information, which is why we are promptly advising you of a recent incident that may have involved your personal information. On February 3, 2019, we discovered a compromise to our website that could have resulted in someone obtaining information about credit card transactions placed through our website between January 16, 2019 and February 3, 2019. You are receiving this notice because you made a purchase through our website during this period of time.			
<b>What Information Was Involved?</b>	The incident could have resulted in someone accessing information entered into our website, including name, address, telephone number, email address and credit card information. This incident did <u>not</u> involve Social Security numbers.			
<b>What We Are Doing</b>	As soon as the issue was identified, we took steps to secure the website and worked with a leading forensic security firm to assist in our investigation. We also have taken several actions to prevent this type of incident from occurring in the future, including reviewing technical security controls.			
<b>What You Can Do?</b>	As a precautionary measure, we recommend that you remain vigilant to protect against potential fraud and/or identity theft by, among other things, reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You should also promptly report any fraudulent activity or any suspected incidents of identity theft to proper law enforcement authorities, including the police and your state’s attorney general, as well as the Federal Trade Commission (“FTC”).			
<b>Other Important Information</b>	<p>You may wish to review the tips provided by the FTC on fraud alerts, security/credit freezes and steps you can take to avoid identity theft. Box 105281, Atlanta, GA 30348. Box 2000 Chester, PA 19022</p> <p><b><u>Fraud Alerts:</u></b> You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least ninety (90) days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Additional information is available at <a href="http://www.annualcreditreport.com">www.annualcreditreport.com</a>.</p> <p><b><u>Credit and Security Freezes:</u></b> You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
