We are writing to inform you of an incident involving Cambridge Healthcare Services, LLC (“Cambridge”) that may have resulted in the disclosure of some of your personal health information. At this time, we are not aware of the misuse of any of your information. Nonetheless, we are notifying you out of an abundance of caution. We take the security of your personal information very seriously and sincerely apologize for any inconvenience this incident may cause.

Cambridge provides administrative and support services to post-acute and long-term care facilities located throughout California, including <<ClientDef1(Covered Entity/Nursing Home Name)>>. If you have not worked with Cambridge directly, we may have obtained limited information about you through one of these nursing/rehabilitation facilities. On November 23, 2018, a Cambridge employee’s laptop computer was stolen. We immediately took action and conducted an investigation to determine what information may have been stored on the stolen laptop and, on December 5, 2018, we discovered that the laptop may have contained your first and last name and limited medical treatment information related to your treatment at one of our affiliated nursing or rehabilitation facilities. However, your medical records and financial account information were not included. We have reported the theft to law enforcement and are cooperating with their investigation.

We take the security of all information in our control very seriously and want to assure you that we are taking steps to prevent a similar event from occurring in the future. Those steps include reviewing and updating our policies and procedures related to information security, ensuring that laptops do not physically store personal health information, encrypting all remaining laptops, and conducting a security risk assessment with security professionals.

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide call center support at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data.



**Free Credit Report.** It is recommended that you remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring your credit report for unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

### **For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents:**

You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

**Fraud Alert.** You may place a fraud alert in your file by calling one of the three nationwide credit reporting agencies above. A fraud alert tells creditors to follow certain procedures, including contacting you before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit.

**Security Freeze.** You have the ability to place a security freeze on your credit report.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may be able to use an online process, an automated telephone line, or a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft.

### **Reporting of identity theft and obtaining a police report.**

**For Iowa residents:** You are advised to report any suspected identity theft to law enforcement or to the Iowa Attorney General.

**For Massachusetts residents:** You have the right to obtain a police report if you are a victim of identity theft.

**For Oregon residents:** You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.
