**Intended Use - to be completed if you checked D, E, F, or G above:**

[1]  For use by a federal, state, or local government agency, including a law enforcement agency, when the information will be strictly limited to carrying out its functions.

[2]  For use by a business or its agents, employees, or contractors in their normal course of business to: (a) verify the accuracy of personal information submitted by the individual to the business or its agents, employees, or contractors; or, (b) if the submitted information is not correct or is no longer correct, to obtain the correct information for the purposes of preventing fraud by pursuing legal remedies against or recovering on a debt or security interest against the individual.

[6]  For use by an insurer, insurance support agency, or self-insured entity in connection with the investigation of claims, antifraud activities, ratemaking, or underwriting.

[7]  For use by a licensed private investigator or security service for any purpose authorized under Montana law.

[9]  To provide notice to the owners of towed, abandoned, or impounded vehicles.

To conduct research activities and produce statistical reports and journalistic articles as long as the personal information is not published, disclosed to a third party, or used to contact individuals.
