I understand that if I have given false information on this application, I may be subject to a fine or imprisonment, or both, under federal and/or state law. This process will extend my expiration date to indefinite. Under MCA 61-5-104; this new license will be valid as long as my military service continues and up to **30 days after my honorable discharge from the military**. I understand this is a free service from the State of Montana and as such, a dishonorable discharge will require re-testing of both the written and drive upon return to Montana to regain my driver license.

There are two options:

- Indefinite expiration of mm/dd/9999 on the driver license and free.
- Expiration date visible on driver license and regular replacement or renewal fees apply. The 30 day exemption will still appear on the back of the license.
