NOTICE OF SABRE DATA BREACH

Dear Valued Customer:

We are writing to inform you of an incident that may have involved your personal information. We take the privacy and security of your information very seriously. This is why we are contacting you and informing you about steps you can take to protect your personal information.

What Happened? The Sabre Hospitality Solutions SynXis Central Reservations system (Sabre) facilitates the booking of hotel reservations made by consumers through hotels, online travel agencies, and similar booking services. These services include reservations for Noble House Hotels & Resorts (Noble House). On May 2, 2017 Sabre informed us that it retained “expert third parties” to investigate a data security incident that may have affected personal information you provided in making reservations at a Noble House property. Sabre informed us that upon discovering the incident, it engaged a digital forensics firm to conduct an investigation. On June 6, 2017, Sabre informed us that certain reservation information may have been accessed between August 10, 2016 and March 9, 2017 without authorization.

What Information Was Involved? The incident may have involved payment card information for hotel reservations, including names, card numbers, card expiration dates, and card security codes.

What We Are Doing: Upon being informed of the incident, we began working with Sabre to determine which of our customers was affected by the incident. We also confirmed that Sabre notified the FBI and the payment card brands in order to prevent fraudulent activity. As set forth below, we are also providing you information about how to protect your personal information.

STEPS YOU CAN TAKE TO FURTHER PROTECT YOUR INFORMATION

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity

As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC).

Copy of Credit Report: You may obtain a free copy of your credit report from each of the three major credit reporting agencies once every 12 months by visiting <http://www.annualcreditreport.com/>, calling toll-free 877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Fraud Alert: You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least 90 days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at <http://www.annualcreditreport.com>.

Security Freeze: In some US states, you have the right to put a security freeze on your credit file. This will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. If you request a security freeze from a consumer reporting agency there may be a fee up to \$10 to place, lift or remove the security freeze. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement.

Additional Free Resources: You can obtain information from the consumer reporting agencies, Federal Trade Commission or from your respective state Attorney General about steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the Federal Trade Commission or to the Attorney General in your state.
