Dear ██████:

We value and respect the privacy of your information, which is why we are writing to advise you of a recent incident that may have involved certain of your personal information. We recently learned that certain of your personal information could have been viewed as part of an email account compromise, when six of our staff email accounts were accessed by an unauthorized party. Upon learning of the incident, we promptly terminated the account credentials. We also retained a leading forensic security firm to investigate and confirm the security of our email and computer systems.

At this point, we are not aware of any fraud or identity theft to any individual as a result of this incident, and do not know if any personal information was actually obtained by an unauthorized party. Nevertheless, because there was an email account compromise and we cannot confirm exactly what, if any, information may have been obtained, we searched impacted accounts for personal information. The compromised email accounts did contain some personal information, primarily information contained in attachments to in-bound emails sent to us by our clients and inter-office email between staff. You are receiving this notice because certain of your personal information was in the affected accounts and could have been accessed, including your name, address Social Security number and, for some people, driver's license number.

Although we are not aware of any instances of fraud or identity theft, we are offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.**

**Fraud Alerts:** You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least 90 days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. **Credit and Security Freezes:** You may have the right to put a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. In addition, you may incur fees to place, lift and/or remove a credit freeze. Credit freeze laws vary from state to state. The cost of placing, temporarily lifting, and removing a credit freeze also varies by state, generally starting at \$5 per action at each credit reporting company. *Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.* Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
